#### **ABSTRACT**

The main thrust of this study was to investigate management variables and service delivery in university libraries in South-South, Nigeria. To achieve this purpose seven research questions were raised and transformed to seven hypotheses to guide the study. Literature was reviewed both theoretically and empirically according to the variables of the study. Correlational research design was adopted for the study. This design was considered appropriate because it gave the researcher the opportunity to study the relationship that exist between two variables; independent and dependent. A total of four hundred and thirty-eight (438) professional and para-professional librarians' were used for the study. The selection was done through the census approach. The questionnaire titled "Management Variables and Service Delivery Questionnaire" (MVSDQ) was the instrument used for data collection. The reliability estimate of the instruments was established through the Cronbach Alpha reliability method. The reliability coefficient ranged from 0.75 to 0.89 which was high enough. Regression analysis was the statistical technique employed to test the hypotheses under study. Each hypothesis was tested at .05 level of significance with relevance degrees of freedom. The result of the analysis revealed that, strategic planning, organizational structure, operational strategies, supervisory techniques, funding and Application of information and communication technology (ICT) significantly relate with service delivery in university libraries. Based on the findings, it was recommended among others that concerned library authorities should provide proper support to the library professionals in the application of ICT and also provide opportunities for staff development on the use of ICT through attendance to seminars, workshops and shot courses to enhance their technical skills for proper implementation and provision of effective and efficient services to the library users. #### **CHAPTER ONE**

#### **INTRODUCTION**

#### 1.1 Background to the study

The principal objective of an academic library is optimal satisfaction of their teeming clientele. Consequently, to achieve this, academic libraries need to be established on an effective management system. Proper management has been identified as core to the growth and sustenance of the library. Certainly, proper management builds efficient organizational structure, sets targets that are testing yet achievable and optimize resource utilization i.e both human and otherwise. It can also ensure an effective workflow as well as increase patronage. Kaehler and Grundeei (2019) affirmed that it is the duty of management to plan, execute and balance its available resources to maximize work output and attain the goals of organization expeditiously. Certo and Certo (2016) defined management as the process of reaching organizational goals by working with and through people and other organizational resources.

Management is coordinating and overseeing the work activities of others so their activities are completed efficiently and effectively (Robbins & Coulter 2016). Managers are assigned with lots of responsibilities to perform toward effective service delivery. They plan using human and material resources to meet organizational objectives within specified time. Thus, the success and failure of organizations lie within their management. Management is concerned with coordinating human and material resources to implement the programmes

and policies of the library. Without adequate management, library's goals of meeting users' information needs will be futile. Management develop strategic plans and coordinate resources to ensure the feasibility of the plans within the shortest possible time.

Consequently, there are different variables that enhance the success of management. Fayol (1949) give five management variables: planning, organizing, staffing, leading and controlling. In the context of this study, the following management variables are considered; strategic planning, organizational structure, operational strategies, supervisory techniques, funding and application of ICT. Petrowicz (2020) avowed that academic libraries need to keep the connection with researchers and further develop functions and remain viable and competitive to provide adequate information to their growing clientele; support effective service delivery; adopt appropriate management variables.

Planning is basically defining the principles of an organization and setting overall objectives. Weihrich, Cannice and Koontz (2008) define strategic planning as a mechanism of envisioning a required future, and changing this goal into ideas or aim and a set of stages to attain them. Mintzberg (2015) describes it as the art and science of developing, implementing and assessing choices that will aid an institution to attain its goals. Enikanselu (2007) views it as the mechanism of stating the reasons of the institution,

forming laws for attaining these goals, and giving materials for executing laws and arrangements to attain the goals of the institution.

Organizational structure is another management variable that enhanced service delivery in academic libraries. The way and manner academic libraries define its structure apparently enhance service delivery. It involves assessment of the jobs to be conducted, setting up a basis of power and role within and among individuals who will perform the job and tye planning of the processes in a situation that they aid the accomplishment of institutional ideas. Johatch (2014) defines organizational structure as the process of how the units of an organization are arranged to ensure orderliness towards the realization of the organization's mission. Kenton and Drury (2020) describe it as a process which joins and regulates persons among the basis of their functions, power and strength. Acharya (2021) views it as a process that lists how some processes are focused in order to attain the vision of an institution, which comprise functions, and accountabilities. It aligns and associates section of an institution, so it can attain its highest activity. The pattern selected affects the organizational progression in conducting its strategic visions. The structure chosen affects the organizational success in carrying out its strategic objectives. It allows groups to work together within their individual functions to manage task.

Operational strategy has been another management delivery. Williams (2018) defines operation strategy as the process an institution executes to attain its prolonged visions and purpose. Reilly (2022) views it as the laws and arrangements for applying the organizations materials to aid its prolonged goals. It must be aligned with the organizational plan and enable it to attain its prolonged arrangement. Boddy (2017) maintain that operational strategy is recognized as a strategic function in academic libraries. It specifies the laws and arrangements for applying the institutions materials to aid its prolonged arrangement.

The strategies put in place by academic libraries to enhance service delivery cannot be achieved without adequate supervision. Supervisory techniques therefore become a *sine quo non* for quality service delivery. Supervisory function is performed with a view to ensuring that subordinates work effectively and efficiently so that the organizational goals can be attained. In this era of information proliferation where information users have multiple access to information, one way management of the library needs to sustain the trust of users in terms of enhancing service delivery is through adequate funding of the library. Adequate funding of the library enhances service delivery. It enables management acquire resources and equipment for effective running of the library. Irenoa, (2019) note that the basis of services is placed largely on the rate of finances at its state and the utilization of the finances. Umar (2013) affirms that proper rates of financing are vital to the

progression of a record in accomplishing its functions. Without comfortable rate of financing over a prolonged level, it is difficult to form laws for service and make the main adequate utilization of accessible materials.

Ebong and Nwachukwu (2014) further pointed out that emphases in this information age are placed on provision of quick delivery of information to users. Chukwudum and Dika (2017) avowed that standard and service delivery is one within the numerous processes that drives the job, which is in agreement with the fifth law of Law of Library Science that says save the time of the users. Therefore, it is vital to document that it is moved mainly on meeting the data requirements and needs of individuals at the adequate period when the requirement arises.

Therefore, management of academic libraries should ensure that quality service delivery is provided to users. Tiemo and Ateboh (2016) reiterated that when information is effectively delivered to users, they not only come back, but also speak well of the library to other individuals. Consequently, for users to view academic library as reliable information repository where relevant data is available for research and study, there is the need for management to provide the above stated variables to enhance service delivery. It is against this backdrop that this study investigates management variables and service delivery in federal university libraries in South-South Nigeria.

#### 1.2 Statement of the problem

Management variables within the library system play a crucial role in defining the efficiency and quality of service delivery. Though there are demanding problems within the domain of library management where the handling of managerial variables, such as formulation of policies for implementation, outline of activities, allocation of functions and duties, reporting lines, integration of modern technologies and monetary allocation, may not be adjusted to meet the evolving needs and expectations of library users. This misalignment between management practices and service delivery requirements raise significant concerns regarding the general effectiveness of libraries in providing timely and relevant services.

The problem may be that university libraries still operate based on outdated management models that do not sufficiently address the dynamic nature of the twenty first century library. This may include issues related to planning, allocation of funds; duties; supervision, collection development, and the integration of digital technologies. As libraries strive to remain relevant in an increasingly digital and information-rich environment, the failure to adapt management practices to these changing dynamics results in inefficiencies, suboptimal service quality, and service failure.

Additionally, variations in management practices across different university libraries may intensify these challenges. The lack of standardized and adaptable management approach hinders benchmarking and best practice sharing, making it difficult to address the problem holistically.

In light of these concerns, there is a critical need for research that examines the relationship between management variables and service delivery in academic libraries. This research aims to investigate strategic planning, organizational structure, operational strategies, supervisory techniques, funding and application of ICT, with a focus on optimizing the overall quality of services provided to academic library users.

Addressing this problem is essential for ensuring that university libraries can continue to accomplish their mission of providing equitable access to relevant, current and adequate information and knowledge in an increasingly digital and information-driven society. By investigating the management variables and their impact on service delivery, this research will contribute to the development of more effective and adaptable management strategies for university libraries, eventually benefiting both library management and users in the university community.

#### 1.3 Purpose of the study

The purpose of the research was to investigate the management variables and service delivery in federal university libraries in South-South, Nigeria. Specifically, the study sought to:

1. determine the relationship between strategic planning and service delivery in federal university libraries in the region.

- 2. investigate the relationship between organizational structure and service delivery in institutions record keeping in the country.
- 3. examine the interaction within operational strategy and service in institutions in the country.
- 4. ascertain the interaction within supervisory techniques and service in institutions in the country.
- 5. find out the interaction within funding and service in institutions records in the country.
- 6. examine the relationship between application of information and communication technology (ICT) and service delivery in institution records in the country.
- 7. determine the joint relationship between planning, organizational structure, operational strategies, supervisory techniques, funding, application of ICT and service delivery in institution libraries in the country.

# 1.4 Research questions

This research sets to answer the following questions:

- What is the interaction within strategic planning and service delivery in institution record keeping in the country?
- To what amount does organizational structure relate with service in institutions in the country?

- 3 How does operational strategy relate with service delivery in institution in the country?
- What is the interaction within supervisory techniques and service delivery in institution records in the country?
- To what extent does funding relate with service delivery in institution records in the region of the country?
- How does the application of information and communication technology

  (ICT) relate with service provision in federal libraries in South-South,

  Nigeria?
- To what extent is the joint relationship between strategic planning, organizational structure, operational strategies, supervisory techniques, funding, utilization of ICT, and service delivery in institution in the country?

### 1.5 Statement of hypotheses

The following hypotheses were formulated and tested at 0.5 level of significance

- There is no interaction within strategic planning and service provision in institution in the region of the country.
- 2. Organizational structure does not have any significant relationship with service delivery in federal university libraries in South-South, Nigeria.

- 3. There is no interaction within operational strategies and service provision in institution in the country?
- 4. There is no interaction within supervisory techniques and services provision in institutions in the country.
- 5. There is no interaction within funding and service provision in institutions records in the country.
- 6. Information and Communication Technology (ICT) does not have any significant relationship with its delivery in institution records in the country.
- 7. There is no significant joint relationship between planning, organizational structure, operational strategy, supervisory technique, funding and utilization of ICT, and its delivery in institution in the country?

# 1.6 Significance of study

The findings of this research may be beneficial to the following groups and individuals; university library management, professional bodies. librarians and researchers.

Management would find this study very interesting as it would enable them formulate and implement policies for optimal service delivery in libraries. It would equip management with adequate knowledge to adjust to emerging

trends in information and communication technology to meet the 21<sup>st</sup> century information needs of users.

This research work may be of benefit to librarians, as it will firstly, enlighten them of their primary obligation to the library. Secondly, educate them on the need to be supportive to management staff and thirdly, imbibe the tenets of quality service delivery to users. It may finally help librarians place the interest of the library and their users above personal interest to enable the library achieve its objectives of satisfying user's information needs.

Professional bodies may find this study of immense, as it would equip them with knowledge on setting the standard for library operations across libraries to ensure effective and quality service delivery with best practices.

Finally, this research will activate additional research, and will function as guide for other scientists who may be interested in carrying out research in similar regions. It would therefore serve as a reference material.

#### 1.7 Scope of the study

The study is delimited to federal universities in South-South, Nigeria. It focused on six [6] management materials and service delivery in the seven institutions in the country. The study covered the following variables: strategic planning, organizational structure, operational strategy, supervisory technique, funding and application of information and communication technology (ICT). Four hundred and forty-eight (448) librarians constituted the population of the study between 2022/2023 academic session.

#### 1.8 Assumptions of the study

The following assumptions are made:

- 1. That the materials under consideration was normally distributed
- 2. That the apparatus used for data collection was valid and dependable.
- 3. That the sample of the study is assumed to be representative of the population.
- 4. That the opinions from the respondents reflect their true feelings

#### 4.9 Limitations of the study

The main limitation of this research was the inadequate character of the respondents in responding to the questionnaire materials due to mixed feelings. This was, however, over come as the researcher was able to convince them that their responses will be used as data for the study only.

#### 4.10 Definition of terms

- 1. Management: A process of setting objectives and planning with accessible individual and materials to ensure realization of set goals and objectives.
- 2. Strategic planning: it is the process of developing, executing and assessing choices that allow a library to attain its visions.
- 3. Organizational structure: is a process that lists how some processes are focused in order to attain the visions of an institution. These processes

- can comprise functions, duties and roles.
- 4. Operational Strategies: The way actions are planned for implementation that describes how different functions are carried out in the organization.
- 5. Supervisory Technique: The method/s adopted by the organization to oversee staff activities.
- 6. Information and Communication Technology (ICT): are apparatus applied for gathering, assessing, storing and availability of data.
- 7. Funding: this is the provision of monetary materials for managing the library.

#### **CHAPTER TWO**

#### LITERATURE REVIEW

# 2.1 Conceptual framework

# **2.2.1** Concept of Management

Prior to the industrial revolution, there was no recognized formal management systems, which meant that activities like coordinating, solely the business owner handled planning, regulating, rewarding, and resource allocation. There was nothing that we would recognize as management practice outside of a few types of organizations, the church, the military, and a sprinkling of significant commerce, building, and agricultural attempts (a significant number of which were unfortunately subject to slave work) (McGrath, 2014).

The modern unrest motivated a critical arrangement of conversation with respect to the executives reasoning. Industrialization happens in each country. It occurred during the nineteenth 100 years in the Unified Realm. Migrants from the Unified Realm took their aptitude with them to Australia.

out, staffing, planning, controlling, coordinating/driving, organizing, and announcing among other more unambiguous capabilities.

Thus, for scholarly libraries to offer quality support conveyance there is the requirement for appropriate administration. Umar (2013) noticed that administration of scholarly libraries as the workmanship and study of forming, executing and examining utilitarian choices that will assist the library with accomplishing its objectives of offering quality support conveyance to clients. In this manner, library the executives consolidates the systems of different practical regions to accomplish its targets. AlDhaheri (2020) asserted that it is the main rate of managerial processes, ordinarily settled by the committee and did by the owners and supervisory group to guarantee quality assistance conveyance to library regard clients.

Buttressing the spot of successful administration in help conveyance, Aboyade and Aboyade (2017) concurred that administration of the library is a continuous cycle, which examinations the library objectives and goals and offer types of assistance in accordance with the library targets outfitted towards meeting the data needs of clients. Afolayan (2021) kept up with that there is vital consistency when the activities of the library is reliable with the expectations of management.

#### 2.2.2 Concept of Service Delivery

It is basic to libraries. They are mechanism and processes that are deployed by records to offer data materials and information to individuals, with

the goal of facilitating the process and creativity of individuals. Alabi and Sani (2021) stated that library what's more, data administration conveyance are library cycles and exercises that are sent by libraries to convey data administrations and assets to clients, fully intent on upgrading the exercises and efficiency of library clients. This could be feasible when libraries have a useful administration that foster plans and activities outfitted in making the library meet its targets inside the most brief conceivable time. Essentially, Onwubiko, Okorie and Onu (2021) kept up with that administration it as sets of particular exercises that mutually and independently add to the turn of events and scattering of data assets to clients.

Eze (2017) presented that assistance conveyance comprises of varieties of exercises and offices designated at giving data in different organizations to fulfill the wide and shifting data needs of library supporters inside the scholastic local area. Issa, (2013) certified that there are administrations that are pointed towards giving clients the right data expected to answer their questions and to assist them with achieving the errand for navigation or decrease of the degree of vulnerability. It was propounded by Birger Wernerfelt (1984) and later formed and assessed by Jay B. Barney (1991). # 2.2.5 Service quality theory (SERVQUAL) by Zeithaml and Berry (1988)

The service quality theory is derived from the work of Zeithaml and Berry (1988). Zeithaml and Berry view administration quality as seen quality as opposed to true quality that is, it is free on the client's impression of what they can anticipate from a help and what they can instead of "objective". accept they have gotten, anv SERVQUALSERVQUAL is a structure used to assess the nature of administrations. It sees five key aspects: Effects (actual perspectives), Unwavering quality (consistency), Responsiveness (practicality), Affirmation (reliability), and Compassion (really focusing on clients).

- 3. Assurance: This aspect connects with the information, capability, and civility of administration workers and their ability to spread respect and validity. It implies possession of the vital capacities and data to perform the aid. Kindness includes neighborliness, regard, thought, and benevolence of contact faculty. It likewise incorporates reliability, acceptability, and trustworthiness of administration workers.
- 4. Empathy: The mindful and individualized consideration gave to clients incorporates the receptiveness and simplicity of contact with the specialist co-ops and their endeavors to grasp the client's requirements.
- 5. Tangibles: Effects incorporate the actual proof of the help, for example, actual offices, appearance of specialist co-ops, apparatuses or hardware used to offer the assistance, actual show of the assistance, and different clients in the assistance office.

By utilizing SERVQUAL, libraries can distinguish regions where they succeed and where upgrades are required, guaranteeing that clients get great administrations. For instance, by zeroing in on factors like effective asset access, accommodating staff collaborations, and the general library climate, libraries can upgrade the client experience and better address the issues of their benefactors.




Figure 2.3: The five key service dimensions of the Servqual Model

Connaway, Harvey, Kitzie and Mikitish, (2017) in their concentrate on audit of vital arranging archives and word related the US. Illustrative pattern was applied in the assessment. The review uncovered that the utilization of Web to library administrations isn't essentially high. The concentrate likewise figured out that the custodians determine fulfillment in the use of Web in their library administrations since it helps for viable administrations conveyance, however a few elements were found to be a prevention for compelling utilization of the Web in the unique records which comprise: low transfer speed; unfortunate subsidizing; flighty power supply, innovation out of date quality and significant expense of network and support.

# 2.4 Appraisal of literature reviewed

This chapter undertook the review of literature on management variables and provision in institution in the country. The study reviewed literature on

strategic planning, organizational structure, operational strategies, supervisory techniques, funding and application of ICT. Strategic planning was seen as a arranged mechanism of picturing a required prospect, and changing this idea into assessed goals or purpose and a set of phases to attain them. The appraised literature on strategic planning revealed a gap in strategic planning in Nigerian academic libraries as most of the reviewed literature were focused on foreign organizations. From the reviewed literature, it was discovered that there was inadequacy in literature and empirical review on long-term strategic plans.

Operational strategy is concerned with information, expertise and capacities which are needed to perform some functions. Its operations are grouped into Top-down approach and Bottom-up approach. Operational strategy is based on establishment of strategic intent, formulation of strategies, implementation of strategies, assessment and regulation. The purpose of operational strategies is to aid tye records actualize the desire and to promote service delivery. Academic libraries operational strategies were not captured in the reviewed literature. Literatures and empirical review basically focused on organization's and companies as academic institutions were not captured.

Supervision strategy involves the stage of management which concentrates mainly on the accomplishment of the adequate administrative and desire of a process. Supervisory technique was seen as a core for the actualisation of organisation goals and objectives. The reviewed literature on supervising strategies revealed inadequacy of empirical review on supervising

strategies in Nigerian academic libraries. It enables management acquire resources and equipment for effective running of the library. Funding is viewed as imperative to organizational growth. The literature reviewed and empirical study further reveals a gap in literatures on funding of university libraries in Nigeria.

The application of ICT was seen as a means of promoting quick and timely access to information. Reviewed literature and empirical review of studies depict an inadequacy of literature on application on ICT in institution records in the country.

The reviewed literatures on planning, organizational structure, operational strategy supervisory strategy, funding and application of ICT focused mostly on organizations and not university records. This revelation has given the prospect for the scientist to fill the missing space considering the importance of management variables in Nigerian university libraries in South South, Nigeria.

#### 3.2 Area of the review

This study was directed in South, Nigeria. The South geo-political zone is prevalently known as the Niger Delta oil region of the country. It comprises of Akwa Ibom. Bayelsa, Cross Stream, Delta, Edo and Waterways states. The zone roughly lies between longitude 5000 and 6045 east and scope 5000 and 6030 north of the country. It is a tropical district, known for weighty precipitation. Others are: 33 experts and 81 para-experts in the College of Benin, 11 experts, 44 para-experts in the Government College, Otueke, 10 experts, 19 para-experts in the College of Oil Assets, and 7 experts and 15 para-experts in Sea College.

# 3.4 Sampling techniques

## 3.6.1 Validity of the instrument

## 3.7 Procedure for data collection

## 3.8 Procedure for data preparation

- 6. Information and Communication Technology (ICT): are apparatus applied for collecting, assessing and availability of data.
- 7. Funding: this is the provision of adequate monetary materials for managing the library.
- 8. Service delivery: this is a mechanism of offering activity to a customer or recipient.

#### 3.11 Ethical considerations

In carrying out the research, data was obtained from the respondents through the use of questionnaire. The respondents were assured of the

confidentiality of their responses and that their opinion would not be distorted. Data from the respondents were secured by ensuring that the copies of the questionnaires were collected and handed over to the analyst. Copies of the questionnaire were collected and kept in a safe place after the analysis for further reference. Acceptable research techniques were used and the results were original and acceptable. Those consulted were acknowledged in the references and copyright laws were in no way violated. The research is void of plagiarism.

The outcome further showed that use of data and correspondence innovation (t=20.813) made the best commitment to support conveyance in college libraries, trailed by financing (t = 1.392), while administrative procedures (t= - .449) made minimal commitment to support delivery in university libraries.

#### 4.3 **Discussion of findings**

This section discussed observations from the results of the analysis. The discussion is displayed in line with the variables of the research.

# 4.3.1 Strategic planning and service delivery in university libraries.
